KEVAL SOUND offers simple INR pricing for listeners, producers, creators, brands, studios, and agencies. All prices listed on this page are in Indian Rupees (INR) and are exclusive of GST.

Applicable GST, taxes, payment charges, or other legally required amounts may be added at checkout and shown separately on your invoice or receipt.

Quick Pricing Summary

- KEVAL RADIO: INR 49/month or INR 441/year when annual billing is selected.
- Standard: INR 299/month or INR 2,691/year when annual billing is selected.
- Pro: INR 499/month or INR 4,491/year when annual billing is selected.
- Enterprise: INR 999/month or INR 8,991/year when annual billing is selected.
- Exclusive song license: INR 99 per eligible song, billed one time per track.

Annual pricing is calculated at 25% off the total monthly price for 12 months and is billed upfront for the year. Monthly pricing is billed every month until cancelled.

GST and Taxes

All KEVAL SOUND prices are GST exclusive unless a checkout page, invoice, or written agreement clearly says otherwise.

This means:

- The listed plan price is the base price before GST.
- Applicable GST may be added at checkout.
- Your invoice or receipt may show the base price, GST, and final payable amount separately.
- If tax rules change, the final checkout amount may change.
- Business customers are responsible for providing accurate billing and tax details.

Example: If a plan is listed as INR 299/month, the final amount payable may be INR 299 plus applicable GST.

Monthly vs Annual Billing

Monthly billing:

- Charged once every month.

- KEVAL RADIO is for listening access only.
- KEVAL RADIO does not include ownership of any song.
- KEVAL RADIO does not include commercial usage rights.
- KEVAL RADIO does not include WAV downloads, sample downloads, stems, or raw source masters.
- To use music in videos, ads, podcasts, films, games, client work, or other content, you need a valid music purchase, license certificate, or separate written license.

Plan 2: Standard

Price:

- Monthly: INR 299/month, GST exclusive.
- Annual: INR 2,691/year, GST exclusive.

Best for:

- Producers who want affordable access to premium exclusive samples.
- Independent musicians and beatmakers who want sounds that are not overused.
- Users who want to browse the premium sample catalog.

Includes:

- Access to studio-grade quality samples.
- Browse premium exclusive sample catalog.
- Exclusive samples for original production.
- Purchased samples disappear from the platform or become unavailable to other buyers.
- Royalty-free usage for purchased samples according to the applicable sample license.

- The Standard plan may unlock sample marketplace access.

- Annual: INR 4,491/year, GST exclusive.

Best for:

- Creators who buy tracks and want tools to customize, edit, and shape purchased music.
- Editors, filmmakers, podcasters, social media creators, and producers who need more creative flexibility.
- Users who want KEVAL RADIO plus sample and creative-tool access.

Includes:

- Includes KEVAL RADIO.
- Monthly exclusive samples.
- Get stems from purchased tracks.
- Edit purchased songs.
- Creative tools for remixing and arrangement.
- Manage purchased tracks in your library.
- Cancel anytime.

- Pro tools apply to eligible purchased tracks and supported assets.

INR 99 Exclusive Song License

The INR 99 exclusive song license is a one-time purchase for an eligible song. It is separate from monthly and annual subscription plans.

What INR 99 means:

- INR 99 is the base price for one eligible exclusive song license.
- The price is GST exclusive.
- Applicable GST may be added at checkout.
- The payment is one time for that eligible song.
- You do not need a subscription to buy an eligible exclusive song license unless a specific product page says otherwise.

What you receive after successful checkout:

- The purchased song is locked from future purchase by other buyers where exclusivity applies.
- The song is added to your KEVAL SOUND account library.
- You receive a license certificate or purchase record.
- You receive a WAV file or another available file format shown at checkout.
- You may be shown as the owner, buyer, collector, or curator of the purchased song inside KEVAL SOUND where owner display is enabled.

What the INR 99 license does not automatically mean:

- It does not automatically transfer full copyright ownership unless the license certificate or a separate written agreement clearly says so.
- It does not automatically transfer publishing rights, composer rights, collection society rights, moral rights, public performance rights, or every possible music right.
- It does not automatically include sample plan access.
- It does not automatically include KEVAL RADIO subscription access.
- It does not guarantee streams, earnings, popularity, placements, or future resale value.

How the rights work:

The buyer receives the usage rights described in the applicable product page, checkout page, license certificate, and Terms of Service. KEVAL SOUND may retain the rights needed to host, store, stream, preview, display, promote, protect, track, and make the song available through KEVAL SOUND, KEVAL Player, KEVAL RADIO, previews, dashboards, and support systems.

This means a purchased song may remain streamable through KEVAL RADIO or KEVAL Player if KEVAL SOUND has retained or secured the required streaming rights.

- You want a low-cost way to explore the streamable catalog.

Choose Standard if:

- You are a producer looking for exclusive samples.
- You want access to premium sample discovery.
- You plan to purchase samples for original production.

Choose Pro if:

- You buy music licenses and want creative tools.
- You want KEVAL RADIO plus monthly exclusive samples.
- You want to edit purchased songs or get stems from supported purchased tracks.

Choose Enterprise if:

- You are a brand, agency, studio, or team.
- You need advanced creative tools and priority support.
- You want a more guided workflow for custom music needs.

Choose the INR 99 exclusive song license if:

- You want to buy one eligible song.
- You want a license certificate and downloadable file.
- You want the track locked from future purchase by other buyers where exclusivity applies.

Billing, Cancellation, and Refund Notes

- Subscriptions renew automatically until cancelled.

- You may cancel subscriptions anytime to stop future renewal charges.
- Cancellation does not automatically refund the current paid billing period.
- Monthly plans are billed monthly unless cancelled.
